SUMMARY OF CHANGES

Block 14 (Description of Amendment/Modification): The purpose of this amendment is to incorporate a revised version of Appendix A of the SOW.

The changes include:

1. Changed from 4 legged tower to 3 legged tower, this was a typo (paragraph 1.1.1.1.8)
2. Added note to place tower as close to existing tower as possible for user FAA certification by end user (paragraph 1.1.1.2.3)
3. Added note indicating swing gate needs to face existing access road (paragraph 1.5.2)
4. Added clarification indicating that only equipment shelter requires shallow foundation, tower requires deep foundations (paragraph 1.1.1.1.9)
