REQUEST 001 FROM: Exterior Metals to Watermark DATE: 04-04-2024

Fabral Inc. would like to request a proposed substitution for the use of 24 GA Stand N Seam 12" x 2" Roofing System. Required product data and performance data has been provided for review.

RESPONSE FROM: Watermark DATE: 04-19-2024

Responses:

Fabral 12" x2" Stand N Seam roofing system is found to be an approved substitution. However, please keep in mind the Contractor must confirm compliance with project Bid Documents and submit signed and sealed shop drawings, color selections by Owner from manufacturer's full range, and only factory formed panels are allowed per specification (no site formed/rolled panels). Please refer to Addendum No 001.

REQUEST 002 FROM: Exterior Metals to Watermark DATE: 04-14-2024

Couple of questions and clarifications for the Justice center:

- 1. Are you requiring shop drawings be sealed by an engineer for this project? Several portable roll-formers are planning on bidding the job using Drexel coils and not sure if they can meet the wind pressures. This might help to prevent confusion. You call out no jobsite forming but Drexel is one of the manufactures and they only provide coils for jobsite forming.
- 2. Are sealed shop drawings also needed for the eave extension framing?
- 3. Wind speed required under IBC 2018 for this job: 176 MPH with Exposure C and Rick Cat 4 (Government facility)?
- 4. The other weathertight warranties I have provided for OB city have been No Dollar Limit weather tight warranties. Will this be the same?
- 5. Will the ISO be 4" standard 20 PSI? No spec in the manual.

- 1. Per specifications Section 076100, 1.2 Submittals, A. Shop Drawings that have been signed and sealed by a Professional Engineer are required for the project.

REQUEST 003 FROM: Berridge Co. to Watermark DATE: 04-22-2024

Berridge Manufacturing Company would like to request a proposed substitution for the use of Double-Lock Zee-Lock roof panel system. The required product data and performance data has been provided for review.

RESPONSE FROM: Watermark DATE: 04-24-2024

Responses:

Berridge Double-Lock Zee Lock roofing system is NOT an approved substitution. The panel width for the submitted double-lock, zee-lock system appears to only be provided in 16" wide, and the City's standard is 12". Likewise, the submitted system does not utilize a two-piece floating clip as specified for expansion and contraction.

REQUEST 004 FROM: Green-Simmons to Watermark

Questions following the Pre-Bid Meeting:

1. When discussing the chain link fence and barb wire that extends up above the finished elevation of the soffit, the owner mentioned that the barb wire would not obstruct the new eave extension and fascia buildout because the new Hardie buildout would reattach to the flat face of the wall where the existing standing seam is to be removed and not at the soffit elevation. Is the area from the bottom of the new blocked out area to the existing soffit area going to have Hardie installed as well. The drawings only show the area where the new buildout will be installed but does not address this portion of the reinstallation from what I can see. Can a drawing be provided that shows how we are to address the construction to avoid obstructing the fencing and wire?

- 2. If the existing plywood has to be fastened and it's covered with ice and water shield, what is the requirement since the existing fastening schedule can't be verified?
- 3. Is it possible to extend the construction duration from 120 days to 240 days in consideration of the building being in use and the requirements this entails?

RESPONSE FROM: Watermark DATE:

- 1. The new cement board siding/fascia/trim does extend for the entirety of the area of standing seam mansard to be removed in all locations. Please see Roof Details on Sheets A500.2 and A500.3 for more information.
- 2. Verification will need to be made of the existing decking, if it cannot be made, then additional fasteners will need to be added (6) #14 Heavy Duty Fasteners at each member (typical).
- 3. The project currently has a duration of 180 calendar days. At this time, this is to remain.

- 2. Introductions Owner Contacts, Architect & Consultants.
- 3. Discussion of Scope of Work The Orange Beach Justice Center Building Roof and Soffit Replacement scopes of work include, but are not limited to, the following. (Note: Contractor is responsible for field verification of all measurements and quantities required to complete bids and installations.)
 - a. Removal of approximately 29,300 square feet of existing standing seam metal roof over a plywood deck.
 - b. Removal of approximately 5,200 square feet of existing standing seam metal fascia.
 - c. Installation of new rigid insulation, plywood coverboard, and self-adhering membrane underlayment over existing plywood deck.
 - d. Installation of approximately 32,500 square feet of new standing seam metal panels, including metal flashings, trims, vents, and curbs to match.
 - e. Installation of new metal framed eave extensions clad with painted cement board soffits and fascia, including all associated flashings and trims.
 - f. Installation of new wood framed eave extensions clad with painted cement board soffits and fascia, including all associated flashings and trims.
 - g. Installation of new gutters and downspouts, colors to be selected by Owner from manufacturers full range.
 - h. Installation of new ornamental brackets, colors to be selected by Owner from manufacturers full range.
- 4. There is a \$20,000.00 Contingency Allowance. Allowances shall be utilized only after advance written approval by the Owner. At the end of the project, any remaining contingency will be returned to the City via Change Order.
- 5. The Bid Form has unit prices for use in unforeseen damaged metal trims replacement and blocking replacement.
- 6. Construction Duration is <u>120</u> 180 Calendar Days from Notice to Proceed.
- 7. Time Extensions such as 'rain days' or unforeseen delays may be submitted for review and consideration.
- 8. Liquidated Damages are defined within Article 23 of Section 00300 Instruction to Bidders within the Project Manual. (\$300 / per day.)
- 9. Before Bidding, Contractor shall verify their license classification of their General Contractors license with the State of Alabama Licensing Board.

- 10. Contractor shall have limited access to the Justice Center as approved by the Owner, but the facility must remain in use for the duration of Construction. Only remove what can be covered and watertight by the end of the workday. Contractor is directed to coordinate all areas of work and scheduling with the City personnel (Glenn) and Justice Center operations.
- 11. Contractor may utilize in moderation, without cost: existing power, electricity and water.
- 12. Contractor will be required to pull a City of Orange Beach Permit, and request inspections accordingly. All fees will be waived.
- 13. Protect all lawns, shrubs, plantings, and concrete sidewalks, pads and paving. Contractor shall be responsible for replacing any plantings and/or concrete that may become damaged through the course of the work. It is advised that the Contractor photo document the area before beginning Construction.
- 14. Remove waste, spoils, surplus materials, rubbish, and construction facilities from the site. On-Site Dumpster location to be coordinated with Owner. Do not use the facility's waste bins or dumpsters. Site must be kept clean daily.
- 15. Any observed discrepancies, omissions or errors in any part of the contract documents shall be submitted as written RFIs to Nic Gray at ngray@watermarkarch.com.
- 16. Cut off time for submission of RFIs is by 3:00 pm Tuesday, April 30th. All requests are to be submitted via e-mail to ngray@watermarkarch.com.
- 17. Cut off time for substitution requests is by 3:00 pm Tuesday, April 30th. Substitution approvals are Pre-Bid only and must have all information for a complete review. All requests are to be submitted via e-mail to ngray@watermarkarch.com.
- 18. Official clarifications, corrections or substitution approvals will be made by written addendum sent to all registered prospective bidders via e-mail. Only clarifications immortalized in Addendums are valid.
- 19. Any discrepancy within the documents not resolved prior to Bidding shall be bid by the Contractor to provide for the most costly and/or restrictive interpretation of the documents.
- 20. Bidding instructions, forms, special requirements and time.
 - a. Sealed Bids will be received and clocked in until 2:00PM local time, **Thursday, the 2**nd **day of May 2024** in the Orange Beach City Hall.
 - b. All Bids not clocked in by the City Clerk's Office prior to the time specified, or Bids received after the specified time, will be automatically rejected, and returned immediately, unopened.
 - c. Bids will be publicly opened and read at 2:00 PM local time, in the Orange Beach City Hall.
- 21. Additional Requirements at time of Contract execution:
 - a. Performance Bond and Labor & Material Payment Bond are required.
 - b. Certificate of Insurance as required by City of Orange Beach (see Project Manual).
 - c. Builder's Risk Insurance:
 - i. ALL RISK Builder's Risk coverage (Property Insurance) shall be provided by the Contractor for the full amount of the Contract during construction, fabrication, storage, transport, erection and work of the Contract. Materials shall be insured at fill value during the storage and

- transportation and not subject to any maximum amounts or occurrence limits.
- ii. Policy provisions and the Certificate of Insurance shall be provided to the Owner.
- iii. Deductible for windstorm shall a maximum of 3%.

23. Questions:

- a. When tearing off the existing roof, do we inspect fasteners?

 Response: Yes, if not code compliant additional fasteners must be added. (6)

 #14 Heavy Duty Fasteners at each Rafter.
- b. Regarding the warranty, would it stand since we are close to the salt water? Response: Yes, the manufactures listed have an Owner's "required maintenance" clause for coastal environments, including saltwater and brackish water, in order to maintain the warranty. All Warranties are still required.
- c. Are eve extensions needed for both purlin and wood framed constructions? Response: Yes. Both are defined within the drawings on Sheet A500.2 and A500.3. Both eve extensions will require signed and seal shop drawings from an Engineer, same as your Roof System shop drawings. We have provided a Basis of Design within the drawing set for use and assistance.
- d. Can the timeframe for the project be extended?

 Response: I spoke incorrectly at the pre-bid, the project timeframe per the Bid

 Documents is one hundred eighty (180) Calendar Days. This is to remain at this

 time
- e. Can the Bid Date move?

 Response: Yes, please refer to Addendum No.1.
- f. Does the "smoker shack" pavilion get a new roof? Response: Yes, please refer to Addendum No.1.
- g. General Notes:
 - i. No smoking on the premises and no talking or interacting with 'guests' in the building or workers in the building.
 - ii. Work hours and times can be coordinated with City of Orange Beacvh and Chief of Police/Operations, but generally a 6:30AM 3:30PM is okay. Contractor will be asked to work around court time(s).
 - iii. No site-rolled panels will be allowed, shop manufactured panels only as specified.
 - iv. Contractor will be required to provide their own sanitation facilities.
